A two-day Festival held in beautiful downtown Pella, IA Friday and Saturday, September 25-26, 2015. Art in the Park, one of the festival's components, will be staged in Central Park which is the center of the activities for the festival.

The Pella Chamber of Commerce will screen applicants' work to ensure a variety and balance of artwork at the show.

ARTIST PARTICPATION REQUIREMENTS

All artwork must be original and created by the artist(s). Art must consist of predominately handmade parts, no buy/resell or imported items are allowed. An artist may only sell his/her own work and may not sub-lease space to other artists.

No electricity will be supplied to booths and generators are not allowed. You must provide your own tents, tables, chairs, display items, etc. The assigned 12' x 12' foot spaces (approximate) are outdoors on grass (placed next to sidewalk for customers to walk on). While the park is beautifully manicured, surfaces may be uneven. Booth structure and displays must not exceed limits of assigned space. You are required to secure your tent with weights.

FEES

Application fee waived for 2015. Booth space (12' x 12') \$40.

ART

Please submit 3 images of current work in each medium you wish to exhibit. Photos (4" x 5" or larger), digital images (JPG format, 300 dpi) will be accepted for the screening process.

LIABILITY

The Pella Chamber of Commerce will not be responsible or liable for injury, theft, loss or damage to property before, during or after the Art in Park event. Artist are responsible for obtaining their own insurance and protection of work and structures.

NOTES

- Working exhibits are welcomed and encouraged!
- The Review Committee reserves the right to remove unsuitable or unapproved artwork. Artists will be allowed to exhibit work consistent with work that has been juried.
- The committee reserves the right to reproduce accepted entries for publicity purposes.
- Please do not bring dogs and pets are prohibited.
